7. The Election Commission will decide the representation of the aggrieved member. 05-08-2024 (Monday)
8. Any person aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the stipulated period, may make an appeal to the Regulator. 08-08-2024 (Thursday)
9. The Regulator shall decide the appeal and his decision in this regard shall be final. 19-08-2024 (Monday)
10. The Final Voters List shall be displayed at Notice Board and Website of the Chamber and shall also be submitted to the Regulator. 21-08-2024 (Wednesday)
