NOTIFICATION

Whereas Rule 11(5) of the Trade Organisations Rules, 2013, mandates that the membership of a trade organisation shall be renewable on an annual basis, subject to the fulfillment of prescribed conditions, including payment of the prescribed subscription fee and submission of requisite tax returns within the stipulated time frame, which shall not be later than 31st March of the respective year.


And whereas, considering the ongoing month of Ramadan and the challenges faced by trade organizations in ensuring timely compliance, the Regulator of Trade Organisations, in the exercise of powers vested under the Trade Organisations Act, 2013, and in accordance with past practices in exceptional circumstances, deems it expedient and in the public interest to extend the deadline for renewal of membership to facilitate trade organizations and their members.

Now, therefore, it is hereby notified that the deadline for renewal of membership of all Trade Organisations registered under the Trade Organisations Act, 2013, is extended from 31st March 2025 to 20th April 2025.

It is further clarified that this extension is a one-time facilitation strictly for the year 2025 and shall not be construed as a precedent for any future relaxation, exemption, or amendment of the Trade Organisations Act, 2013 or the Trade Organisations Rules, 2013.

Trade Organisations are advised to ensure compliance within the extended timeframe and to take all necessary measures to facilitate their members accordingly.

This notification is issued with the approval of the Regulator, Trade Organisations.
